Junior Gold Championships Qualifier

For 2024 Jr. Gold Championships to be held July 12-20, 2024 in Detroit, MI

Advancement ratio is 1 in 5.

Up to Six Divisions offered:

U18 Boys & U18 Girls ~ Combined if inadequate entries received

U15 Boys & U15 Girls ~ Combined if inadequate entries received

U12 Boys & U12 Girls ~ Combined if inadequate entries received

Partial qualifier advancement available dependent upon number of entries.

(Additional fees may apply)

Must be a Junior Gold member to participate in qualifier (Membership sold on site)

U18 & U15 membership—\$30.00

U12 membership— \$10.00

Tournament Rules:

1. All current USBC Youth members are eligible to enter.
2. Jr. Gold participation is not required to bowl in this tournament.
3. Jr. Gold entrants MUST be current Jr. Gold members or purchase membership on site.
4. Tournament format is 5 (five) games. Total score PLUS Handicap shall determine winners. Scratch scores shall be utilized to determine Jr. Gold Advancers. Ties for Jr. Gold Advancers shall utilize a 9th & 10th frame roll-off until winner determined. Ties for Handicap shall be combined and shared equally.
5. Handicap shall be 80% of 220 based on the following:
 - a. 2022-23 composite average
 - b. Current league average (12 game minimum) (MUST bring current standing sheet)
 - c. 2021-22 composite average
 - d. If none of the above apply, bowler shall bowl Scratch (220 average).
6. Average reporting SHALL BE the responsibility of the bowler. Failure to report proper average will result in automatic rerate to Scratch Bowler.
7. Prize Fund to be distributed 100% in the form of SMART Scholarship funds (Account #9176).
8. All decisions made by Tournament Director are FINAL. TD has the right to deny/refuse any entry, re-rate/disqualify any bowler if necessary, or cancel tournament due to lack of participation.
